SEPTEMBER 15th, 2017 12pm to 10pm & SEPTEMBER 16th, 2017 10am to 10pm

The city of North Wildwood ordinance 1433 states in part, "Each Vendor .. must register his or her own location and pay the appropriate fee for each festival ... All vendors must have the approval of the sponsoring organization to vend at their location."

MERCHANDISE

ALL PRODUCTS MUST BE COUNTRY/WESTERN OR HAVE THE APPROPRIATE THEME FOR THE FESTIVAL. THE ANGLESEA IRISH SOCIETY HAS THE RIGHT TO REJECT ANY APPLICATION THE SOCIETY DOES NOT FEEL MEETS THE STANDARDS OF THE FESTIVAL. DEROGATORY SLOGANS, WRITING OR PICTURES ON ANY ITEMS INCLUDING BUT NOT LIMITED TO CLOTHING, SOUVENIRS OR POSTERS, DEPICTING THE NATURE OF THE FESTIVAL IN A DEGRADING OR INSULTING WAY WILL NOT BE PERMITTED TO BE SOLD. ANY VENDOR WHO IS REPORTED AS SELLING THESE ITEMS WILL BE REMOVED FROM THE PREMISES AND ANY MONEY'S PAID WILL BE FORFEITED. ALL MERCHANDISE MUST BE APPROVED PRIOR TO THE FESTIVAL. THE BOOTS AT THE BEACH LOGO AND/OR TITLE CAN NOT BE USED ON ANY MERCHANDISE.

STREET SET UP:

- All vendors tables will set up in the center of Olde New Jersey Ave between Spruce and Chestnut Street & will be given a themed table cloth that must be used for the duration of the festival.
- All vendor spot numbers will be clearly marked in the center of Olde New Jersey Avenue
- All vendors are responsible to provide their own tables and tents.
- Vendors must unload their products, tents and tables; remove their vehicles and return to set up their stand. One vehicle per vendor.
- Space Sizes: Single Spot is 10 feet by 10 feet & Double Spot is 10 feet by 20 feet

TABLE FEES (NON- FOOD VENDORS):

Single Spot (10 x 10) - \$285.00 (includes North Wildwood permit fee)

Double Spot (10 x 20) = \$495.00 (includes North Wildwood permit fee)

**Fees do NOT include electrical costs.

NEED ELECTRIC?

If you are in the need of a 20, 30, or 50 AMP of power for the weekend – there will be a fee assessed from the City of North Wildwood.

1 x 20 AMP is \$50 per day

1 x 30 AMP is \$75 per day

1 x 50 AMP is \$100 per day

FOOD VENDORS

All food vendors will be a cost of \$500.00 dollars for Friday and Saturday

The fee does **NOT include your Fire Permit of \$42.00 or any electrical costs. See above for electrical costs per day.

HOURS OF OPERATION

- Friday 12pm to 10pm *set up information will be sent out a few weeks before the event
- Saturday 10am to 10pm *set up information will be sent out a few weeks before the event
- All VENDORS must participate in BOTH days – there will be no one day fees.

NEW JERSEY STATE TAX NUMBER

- All vendors are recommended to have a New Jersey State tax number in your possession at the festival. As always, The State Department of Taxation will be at the festival to inspect this document.

INSURANCE

- All non-food vendors are strongly encouraged to have insurance of not less than \$100,000.00 combined liability and property damage, including products and completed operations.
 - o All vendors will be required to sign a waiver of liability form if a vendor does not get their own insurance for the event.
- **All food vendors must** have insurance of not less than \$500,000.00 combined liability and property damage, including products and completed operations. 5 Mile Isle Events, LLC and the Anglesea Irish Society must be listed in your insurance rider.

RESERVATIONS

- All reservations must be accompanied by a full amount non-refundable deposit
- Due Date for all Vendor Applications will be August 1st, 2017
